FOREWORD

This publication sets forth all of the requests made by the Hawaii State Legislature during the Regular Session of 2010 to agencies and officials of the federal, state and county governments and of quasi-public and private agencies. These requests are contained in acts enacted by the Legislature or bills passed which have yet to be approved by the Governor. These acts or bills include specific requests for submission of information back to the Legislature excluding annual and other reports requested on an indefinite basis. These requests are also contained in resolutions adopted by the Senate or House of Representatives or by the whole legislature. Dates by which reports and other responses are expected are indicated when specifically set by the Legislature. The names of the agencies involved in the conduct of a study or the execution of a request are underscored.

For the reader's convenience these legislative requests are also grouped together by agencies (see agency index); as well as by subject matter (see subject index).

SB 2501, SD1, HD1

CERTIFIED PUBLIC ACCOUNTANT, PEER REVIEW RULES FOR. Requires the Board of Public Accountancy to adopt rules pursuant to chapter 91 to establish requirements and procedures for the qualification of entities to conduct peer reviews and for the performance of peer reviews that include:

- (1) A process for the conduct of peer review to be followed by the Board and by an authorized third party entity;
- (2) Definitions, standards, and requirements for an acceptable peer review;
- (3) Standards for certification and qualification of peer reviewers;
- (4) A process for a firm to appeal the findings or conclusions of any peer review process that results in the denial, termination, or nonrenewal of a firm permit pursuant to section 466-9; provided that the appeal process shall include the postponement of any adverse action during the pendency of the appeal; and
- (5) Provisions for the grant of an extension of time to a firm for compliance with the peer review requirement based on a showing of hardship including for reasons of health, military service, or other good cause as determined by the Board.

Requires the Board to report the adoption of the rules to the Legislature immediately upon adoption of those rules by means of written notice to the Speaker of the House of Representatives and the President of the Senate.

PART II, SECTION 3

ENERGY SECURITY SPECIAL FUND, PROGRAMS AND ACTIVITIES FUNDED BY.

Requires the Department of Business, Economic Development, and Tourism to submit a report on the status and progress of existing programs and activities and the status of new programs and activities funded by the special fund that includes:

- (1) The spending plan of the energy security special fund;
- (2) All expenditures of energy security special fund moneys; and
- (3) The targeted markets of the expenditures, including the reason for selecting those markets; the persons to be served; and the specific objectives of the expenditures, including measurable outcomes

to the Legislature no later than twenty days prior to the convening of each Regular session. (Repealed on June 30, 2015.)

PART III, SECTION 6

ENERGY AND FOOD POLICY AND PROGRAM DEVELOPMENT. Establishes the Hawaii Economic Development Task Force within the Department of Business, Economic Development, and Tourism for administrative purposes to facilitate the accelerated adoption and completion of renewable-energy projects, energy-efficiency programs, agricultural infrastructure and development, and other measures to meet the purposes of this Act.

Requires the Task Force to develop and maintain a broad overview of energy and food security issues that apply an interdisciplinary approach to ensure that Hawaii's energy and food policy and program development is integrated within the overall economic, social, environmental, and cultural aspects of society and with the assistance of the Department to:

- (1) Identify and review each state and county agency's policy objectives, mandates, organizational structure, and resources to address energy and food security issues;
- (2) Identify all federal and private funds available to the State and counties to address energy and food security issues;
- (3) Identify effective measures for interagency cooperation, coordinate efforts with the counties, and promote public- and private-sector partnerships to achieve the objective of energy and food security;
- (4) Identify existing programs and agreements addressing energy and food security that may be enhanced through legislation;
- (5) Investigate alternative institutional mechanisms to promote the efficient execution and implementation of a multi-year strategy to achieve energy and food security;
- (6) Investigate the streamlining of administrative processes to accelerate and achieve energy and food security;
- (7) Provide an appropriate forum for all affected or interested parties to address energy and food security issues;
- (8) Recommend appropriate legislation resulting from its findings to improve, accelerate, and achieve the objective of energy and food security;
- (9) Review whether:
 - (A) The apportionment of the environmental response, energy, and food security tax among the funds listed under section 243-3.5, Hawaii Revised Statutes, is appropriate;
 - (B) The apportionment should be changed; and
 - (C) Any additional special, trust, or revolving fund should receive a share of the tax; and
- (10) Perform any other function necessary to effectuate the purposes of this part.

Requires the Task Force to consist of:

- (1) The Director of Business, Economic Development, and Tourism or the Director's designee, who shall chair the Task Force;
- (2) The Chairperson of the Board of Agriculture or the Chairperson's designee;
- (3) The Director of the Office of Planning or the Director's designee;
- (4) The Chairperson of the Board of Land and Natural Resources or the Chairperson's designee;
- (5) The Dean of the University of Hawaii College of Tropical Agriculture and Human Resources or the Dean's designee;
- (6) Three members to be designated by the Speaker of the House of Representatives;
- (7) Three members to be designated by the President of the Senate; and
- (8) A representative from each county's private economic development board.

Requires the Task Force to submit a report of its findings and recommendations, including any proposed legislation, to the Legislature no later than twenty days prior to the convening of the Regular Session of 2011.

Further requires the Task Force to submit a follow-up report which includes a description of the activities funded by the environmental response, energy, and food security tax, progress made toward energy and food self-sufficiency, and any additional action necessary to achieve energy and food self-sufficiency to the Legislature no later than twenty days prior to the convening of the Regular Session of 2012

PART IV, SECTION 7

AGRICULTURAL DEVELOPMENT AND FOOD SECURITY SPECIAL FUND, PROGRAMS AND ACTIVITIES BY. Requires the Department of Agriculture to submit a report on the status and progress of existing programs and activities and the status of new programs and activities funded under the special fund which includes:

- (1) The spending plan of the agricultural development and food security special fund;
- (2) All expenditures of agricultural development and food security special fund moneys;
- (3) The targeted markets of the expenditures, including the reason for selecting those markets;
- (4) The persons to be served using the expenditures; and
- (5) The specific objectives of the expenditures, including measurable outcomes

to the Legislature no later than twenty days prior to the convening of each Regular Session. (Repealed on June 30, 2015.)

PART VIII, SECTION 11

ENVIRONMENTAL RESPONSE, ENERGY, AND FOOD SECURITY TAX. Requires the Department of Business, Economic Development, and Tourism to study and analyze tax including its amount and allocation, and its effectiveness in accomplishing the goals and objectives of this Act and report its findings and recommendations, including any proposed legislation, to the Legislature no later than twenty days prior to the convening of each Regular Session, ending with the Regular Session of 2015.

ACT 75

HB 1862, HD1, SD1, CD1

URINATING AND DEFECATING IN DOWNTOWN HONOLULU. Requests the Honolulu Police Department to prepare a report on the offense of urinating and defecating in public within the boundaries of the downtown Honolulu area established by this Act that shall include but not be limited to:

- (1) The effectiveness of the offense established by this Act in deterring the conduct proscribed; and
- (2) The number of citations issued for this offense for the two years preceding the date of the report;

and to submit the report to the Legislature no later than twenty days prior to the convening of the Regular Session of 2012.

(HSCR 237-10, SSCR 2866, CCR 8-10)

ACT 82

HB 347, HD2, SD2, CD1

UNIVERSITY OF HAWAII'S PROCUREMENT PROCESS. Requires the Board of Regents of the University of Hawaii to submit annual reports that includes:

- (1) A description of the University's internal procurement process;
- (2) A description of the University's internal procedures for handling protests of solicitations or awards of contracts, if different from the procedures described under chapter 103D, Hawaii Revised Statutes; and
- (3) A description and summary of any protests or litigation that have arisen during the period of time that the University is exempt from chapter 103D, Hawaii Revised Statutes;

to the Legislature no later than twenty days prior to the convening of the Regular Sessions of 2011 and 2012.

SB 1059, SD2, HD3, CD1

FIREWORKS. Establishes an Illegal Fireworks Task Force within the Legislative Reference Bureau to develop a plan and make recommendations to stop the importation of illegal fireworks and explosives and to develop a strategy to ensure the safety and security of the airports, harbors, and other facilities and institutions in this State against the discharge of illegal fireworks and explosives.

Requires the co-chairs of the Task Force to be the Chair of the Senate Committee on Public Safety and Military Affairs and the Chair of the House Committee on Public Safety and requires the Governor, the President of the Senate, and the Speaker of the House of Representatives to each appoint one member.

Requires that two additional members of the Task Force be representatives of the shipping and trucking industries and another two additional members of the task force be representatives of the fireworks industry.

Further requires the Task Force to submit a preliminary plan and strategy report to the Legislature no later than January 10, 2011.

SB 2068, SD2, HD1, CD1

JUNIOR KINDERGARTEN PROGRAMS ASSESSMENT PLAN. Requires the Department of Education and Early Learning Council to work together to develop a plan to assess the success of public junior kindergarten programs at individual schools and to submit the plan and any proposed legislation to the Legislature no later than twenty days prior to the convening of the Regular Session of 2011.

(SSCR 2327, 2625, HSCR 885-10, 1154-10, CCR 128-10)

SB 2187, SD1, HD2, CD1

HAWAII TOURISM AUTHORITY'S CONTRACTS AND AGREEMENTS. Requires the Hawaii Tourism Authority to periodically submit a report on contracts and agreements entered into by the Authority to the Governor, the Speaker of the House of Representatives, and the President of the Senate.

(SSCR 2051, 2565, HSCR 703-10, 217-10)

SB 2220, SD1, HD2, CD1

CONSTRUCTION SITE INSPECTION TASK FORCE. Requires the Director of Commerce and Consumer Affairs to convene a construction site inspection task force that includes at least two representatives each from the Office of the Attorney General; the Department of Commerce and Consumer Affairs; the Disability Compensation Division, the Occupational Safety and Health Division, and the Unemployment Insurance Division of the Department of Labor and Industrial Relations; the Department of Taxation; and a requested representative from each county permitting department.

Requires the task force:

- (1) Discuss, research, and report on the advantages of sharing among the participating agencies information necessary to combat unlicensed contracting, the use of undocumented workers, and workplace safety violations, including a discussion of the potential advantages and disadvantages of a shared automated information database systems, common case numbers, and a centralized debt collection system;
- (2) Discuss, research, and report on ways to improve the coordination of activities among the participating agencies;
- (3) Discuss, research, and report on ways to develop methods to pool, focus, and target the enforcement resources of the participating agencies to deter tax evasion, unlicensed contractor activity, and workplace safety violations and to maximize recovery of penalties for violations of laws and rules; and
- (4) Discuss, research, and report on ways to reduce enforcement costs wherever possible by eliminating duplicative audits and investigations.

Further requires the task force to submit a report on its findings and recommendations on implementing a task force to investigate and inspect construction sites for unlicensed contractors, undocumented workers, and workplace safety violations to the Legislature no later than sixty days prior to the commencement of the Regular Session of 2011.

SECTION 4

TEACHER LICENSE FEES. Requires that if the Hawaii Teacher Standards Board determines that the increased revenue is not sufficient to fund fully the expenses of the

Board, the Board shall submit a plan and timetable for increasing the license fees to the Legislature no later than twenty days prior to the Regular Session of 2011.

SECTION 5

HAWAII TEACHER STANDARDS BOARD TRANSFER OF NONESSENTIAL FUNCTION. Requires the Hawaii Teacher Standards Board to develop a comprehensive plan for transferring nonessential functions and duties to other agencies and submit the plan to the Legislature no later than twenty days prior to the Regular Session of 2011.

SECTION 6

TEACHER LICENSE RENEWAL PROCESS. Requires the Hawaii Teacher Standards Board to review its teacher license renewal process and determine whether the Board should:

- (1) Modify the licensing standards;
- (2) Modify its approach in determining whether a renewal applicant is in compliance by having satisfied all the standards; or
- (3) Recommend amendments to section 302A-805(a), Hawaii Revised Statutes, to conform to the Board's present requirements for license renewal and thus eliminate the conflict with the statute; and

submit findings and recommendations to the Legislature no later than twenty days prior to convening of the Regular Session of 2011.

SECTION 7

HAWAII TEACHER STANDARDS BOARD AND THE DEPARTMENT OF EDUCATION. Requires the Hawaii Teacher Standards Board and the Department of Education to clarify their respective powers, duties, responsibilities, and the relationship between the two agencies and for the Board to submit findings and recommendations to the Legislature no later than twenty days prior to the Regular Session of 2011.

(SSCR 2367, HSCR 778-10, CCR 89-10)

SB 2469, SD2, HD2, CD1

HOUSING FIRST PILOT PROGRAM FOR THE CHRONICALLY HOMELESS. Requires the Hawaii Public Housing Authority in collaboration with the Department of Human Services to submit a report to the Legislature on the progress of the housing first pilot program no later than twenty days prior to the convening of the Regular Session of 2011.

(SSCR 2270, 2586, HSCR 846-10, 1191-10, CCR 158-10)

SB 2472, SD2, HD1, CD1

MORTGAGE FORECLOSURES. Establishes a mortgage foreclosure task force within the Department of Commerce and Consumer Affairs for administrative purposes and requires the Director of Commerce and Consumer Affairs to select the initial members of the task force and shall invite at least one member from each of the following:

- (1) The Department of Commerce and Consumer Affairs' Office of Consumer Protection;
- (2) A mortgage counseling organization approved by the United States Department of Housing and Urban Development, preferably with expertise in consumer credit counseling;
- (3) The Legal Aid Society of Hawaii;
- (4) The Hawaii Financial Services Association;
- (5) The Hawaii Bankers Association;
- (6) The Mortgage Bankers Association of Hawaii;
- (7) The Hawaii Credit Union League;
- (8) The Hawaii Council of Associations of Apartment Owners;
- (9) The Hawaii State Bar Association Collection Law Section;
- (10) The Hawaii State Bar Association Bankruptcy Law Section or the Bankruptcy Court of the United States District of Hawaii; and
- (11) The Hawaii State Judiciary.

Requires the task force to undertake a study to develop both general and specific policies and procedures necessary to improve the manner in which mortgage foreclosures are conducted in the State.

Further requires the task force to analyze the effectiveness and any defects of the foreclosure procedures currently set in statute for both judicial and power-of-sale foreclosures.

Further requires the task force to comment on the feasibility of establishing a state entity or administrator to focus on addressing the concerns of mortgagors, disseminating information, and otherwise engaging in consumer education and to propose funding mechanisms to enable the operation of this entity.

Further requires the task force to submit a report of its findings and recommendations, including any proposed legislation, to the Legislature no later than twenty days prior to the convening of the Regular Sessions of 2011 and 2012.

Requires the Legislative Reference Bureau to assist the task force in preparing its findings, recommendations, and proposed legislation.

SB 2491, SD2, HD1, CD1

TELEHEALTH SERVICES IMPACT ON MALPRACTICE INSURANCE PREMIUM RATES. Requires the Insurance Commissioner to study the impact of coverage of telehealth services under medical malpractice policies and its impact on malpractice premium rates in various states across the country and in Hawaii and report findings, recommendations, and any proposed legislation to the Legislature no later than twenty days prior to the convening of the Regular Session of 2011.

(SSCR 2139, 2418, HSCR 871-10, 1138-10, CCR 132-10)

SB 2548, SD2, HD1, CD1

INFORMATION OFFICER AND SHARED SERVICES TECHNOLOGY FUND.

Requires the Governor to report recommendations for:

- (1) The most appropriate state agency to house the chief information officer and any personnel under the authority of the chief information officer; whether as the executive of a separate agency or as part of an existing agency;
- (2) The appropriate funding level for the shared services technology special fund established in section 27- (c), Hawaii Revised Statutes, and the designated percentage of all moneys collected pursuant to section 36-27(a), Hawaii Revised Statutes, for deposit into the shared services technology special fund; and
- (3) Any legislation necessary to implement these recommendations to the 2011 Legislature.

ATHLETIC TRAINERS. Requires the Auditor to analyze the probable effects of a proposed regulatory measure to regulate the profession of athletic trainers and the issues entailed in the definition and scope of practice of an athletic trainer and make recommendations on whether athletic trainers should be regulated.

Further requires the Auditor to submit reports to the Legislature no later than twenty days prior to the convening of the Regular Session of 2011.

(SSCR 2390, HSCR 737-10, 850-10, 1216-10, CCR 102-10)

SB 2811, SD2, HD2, CD1

PHARMACIES, VACCINATION OF MINORS, ELECTRONIC RECORDS, AND PARTICIPATION IN THE HAWAII HEALTH INFORMATION EXCHANGE. Requires the Chair of the Board of Pharmacy to establish a task force to conduct a study to determine the feasibility of lowering the age at which vaccinations may be administered by pharmacists; assess the feasibility of requiring every pharmacy and remote dispensing pharmacy to have the capacity to transmit and maintain prescriptions and prescription information electronically; and develop a plan for pharmacy participation in the Hawaii Health Information Exchange.

Further requires the task force to conduct research, assess, plan, and evaluate:

- (1) The potential benefits and drawbacks of lowering the age restrictions for pharmacists to administer vaccines to children;
- (2) The most effective means to lower such age restrictions;
- (3) Whether additional education or certification requirements for vaccinating pharmacists would be necessary or recommended;
- (4) Schemas of other states' vaccination age restrictions that allow vaccination of minors by pharmacists in all or limited circumstances;

- (5) The feasibility, costs, and benefits of requiring every pharmacy and remote dispensing pharmacy to have the capacity to transmit and maintain prescription and prescription records electronically and a time frame for implementing this requirement; and
- (6) A plan to include pharmacy participation in the Hawaii Health Information Exchange.

Further requires the task force to submit a report of its findings and recommendations, including any implementing legislation, to the Legislature no later than twenty days prior to the convening of the Regular Session of 2011.

Requires the task force to be chaired by the Director of Health or the Director's designee and shall comprise:

- (1) One member of the Board of Pharmacy;
- (2) Two members of the Hawaii Pharmacists ;
- (3) Two pharmacists from chain store pharmacies, including one pharmacist from a national chain store with experience in pharmacy-administered vaccinations to pediatric recipients as young as nine years of age, and one pharmacist from each of two independent pharmacies; provided that the participating pharmacies shall be selected by the task force;
- (4) One member of the American Academy of Pediatrics, Hawaii Chapter; and
- (5) One member from the Hawaii Health Information Exchange.

SB 2885, SD2, HD1, CD1

HEALTH INSURANCE SAVINGS ACCOUNTS. Establishes the health savings accounts assessment task force within the Department of Labor and Industrial Relations consisting of:

- (1) The Director of Labor and Industrial Relations, who shall appoint the task force members by August 1, 2010;
- (2) Two members of the Hawaii Prepaid Health Care Advisory Council;
- (3) One member or employee of the Hawaii Medical Association;
- (4) Two representatives from the health insurance industry;
- (5) Two representatives from non-government employee unions;
- (6) One representative from the Hawaii Credit Union League;
- (7) One representative from the Hawaii Bankers Association; and
- (8) Two representatives from other interested organizations or stakeholders, at the discretion of the Director of Labor and Industrial Relations.

Requires the task force to:

- (1) Study the current state of health savings account options in Hawaii's health insurance market;
- (2) Establish a plan of action to encourage and expand the use of health savings accounts in Hawaii, including potential amendments to the Hawaii Revised Statutes;
- (3) Identify and recruit health plans that may help expand the availability of health savings accounts in Hawaii;
- (4) Assess the potential economic impact, including costs and benefits, of expanding

health savings account options in Hawaii, and estimate the potential monetary savings for individuals and employers who are offered health savings accounts; and

- (5) Work to develop a way to implement flexible spending accounts for employee benefit programs that provide a tax deferred method of payment for eligible health care expenses and dependent care expenses by directing pre-tax money from an employee's paycheck into flexible spending accounts, and providing that money left in the flexible spending accounts after all reimbursements have been processed may be carried forward to the next plan year.

Further requires the task force to submit through the Department, its findings and recommendations, including any proposed legislation to the Legislature no later than twenty days prior to the convening of the Regular Session of 2011.

SB 2919, SD1, HD1, CD1

HAWAII STATE HOSPITAL SECURITY. Requires the Director of Health in collaboration with the Director of Public Safety to submit a report on:

- (1) The plan, strategies, and timetable for ensuring the provision of appropriate levels of security at the Hawaii State Hospital over the long term; and
- (2) Short- and long-term strategies and plans to address the State's increasing and aging forensic population of the Hawaii State Hospital, including but not limited to facility needs, capacity issues, and other off-site options

to the Legislature no later than twenty days prior to the convening of the Regular Session of 2011.

(SSCR 2256, 2442, HSCR 723-10, 878-10, 1185-10, CCR 83-10)

HB 415, HD2, SD2, CD1

PRISONS, AUDIT. Directs the Auditor to conduct an audit of the Department of Public Safety's contracts for prison beds and services outside of Hawaii, focusing on a comparison, in terms of quality of programming, costs, and economic benefit to the state, with housing Hawaii inmates in Hawaii facilities operated by the State.

Requires the Auditor to also conduct an audit of the Department's contract with the federal detention center in Honolulu, focusing on a comparison, in terms of quality of programming, costs, and economic benefit to the state, with housing Hawaii inmates in Hawaii facilities operated by the State and to:

- (1) Address the closure of the Kulani correctional facility as part of its analysis in conducting this comparison; and
- (2) Make a recommendation on whether the continued housing of Hawaii inmates in mainland facilities and in the federal detention center in Honolulu is advisable, in view of the explicit requirements of Chapter 353H, Hawaii Revised Statutes, Community Safety Act of 2007, and its subsequent amendments.

Further requires the Auditor to report its findings and recommendations to the Legislature no later than twenty days prior to the convening of the Regular Session of 2011.

HIGHWAY MAINTENANCE, TRANSFER TO THE COUNTIES. Further requires that the group submit a report that contains the findings and recommendations of the feasibility study, including any problems, implementation plans, necessary legislation, and any other relevant information or issues concerning the transfer of all applicable state highway maintenance functions to counties with populations that, according to the United States Census Bureau, had a population between one hundred thousand and one-hundred thirty-five thousand in the 2000 Census to the Legislature no later than twenty days prior to the convening of the Regular Session of 2011.

- (2) The name, location, and description of any housing projects, including the number and types of housing units, and the projected delivery date of the units in each project, that have benefitted from the obligations incurred in paragraph 1; and

CHRONIC DISEASE MANAGEMENT CONTROL. Requires the Department of Health to prepare a detailed report on the expenditures for this program and submit the report to the Legislature no later than twenty days prior to the convening of the Regular Session of 2011.

PART III, SECTION 28.2

HAWAII TOBACCO PREVENTION AND CONTROL TRUST FUND. Requires the Department of Health to prepare a detailed report that shall include but not be limited to:

- (1) The contract between the Department and the administrator of the trust fund;
- (2) A description of the financial condition of the fund;
- (3) Investment policies;
- (4) Detailed lists of all grant awards and expenditures;
- (5) A detailed explanation on requirements for qualifying for grants; and

and that the Department submit the report to the Legislature no later than twenty days prior to the convening of the Regular Session of 2011.

PART III, SECTION 34

MARRIAGE REGISTRATION SYSTEM. Requires the Department of Health to prepare:

- (1) a detailed report on the funds appropriated to automate the marriage registration system in fiscal year 2009-2010 and fiscal year 2010-2011; and
- (2) an implementation plan including but not limited to milestones, milestone dates, projected completion dates, and progress made;

and that the Department submit the report and implementation plan to the Legislature no later than twenty days prior to the convening of the Regular Session of 2011.

PART III, SECTION 39

CHARTER SCHOOLS. Requires charter schools to prepare a report that shall include but not be limited to a detailed breakout of the all means of financing budget for the current and next fiscal year and actual expenditures for the last completed fiscal year for each charter school, a report of all other funds expended on behalf of each school, and a report detailing by school:

- (1) The enrollment projections used to submit the current budget request;
- (2) The actual October 15, 2010 enrollment count as reported by each school for the current school year;
- (3) The charter school administrative office's reviewed and verified October 15, 2010 enrollment count; and
- (4) The Charter Schools Administrative Office's reviewed and verified November 15, 2010 enrollment count

and provides that the Office submit these reports to the Legislature no later than twenty days prior to the convening of the Regular Sessions of 2010 and 2011.

PART III SECTION 39.1

CHARTER SCHOOLS, FACILITY COSTS. Requires charter schools to prepare a report that shall include but not be limited to a detailed breakout of actual facility-related expenditures for the last completed fiscal year for each charter school and the method of funding; and provides that the Charter Schools Administrative Office submit the report to the Legislature no later than twenty days prior to the convening of the Regular Session of 2011.

PART III, SECTION 41.1

HAWAII NATIONAL GUARD YOUTH CHALLENGE ACADEMY. Requires the program to give preference to students from the Department of Education and that the Department prepare a report which itemizes, by educational organization immediately previously attended, the number of applicants and the number of those applicants accepted by the program for each of the previous two school cycles and submit the report to the Legislature no later than twenty days prior to the convening of the Regular Session of 2011.

Requires the Department of Education to prepare a report detailing each consultant contract executed during each fiscal year, including but not limited to each service provider's name and contact information, general contract terms, scope of contract, contract cost, contract duration, and status and accounting of work performed and submit the consultant contract report to the Legislature no later than twenty days prior to the convening of the Regular Session of 2011.

TRAVEL RELATED EXPENSES. Requires the Department of Transportation to prepare a report on all travel-related expenses compensated by non-state organizations by program I.D. that includes a detailed list of each instance of travel identifying:

- (1) Position traveling and the purpose;
- (2) Destination and departure and arrival dates;
- (3) Itemization of all compensated costs and the value; and
- (4) Organization compensating the travel and the reason.

Further requires the report to encompass travel from December through November preceding the date of the report and be submitted to the Legislature no later than twenty days prior to the convening of the Regular Session of 2011.

- (3) The basis for distribution formulas and discretionary distribution and parties involved in determining said distributions;

- (6) An analysis on how increased capital improvement expenditures can increase the federal indirect rate and estimates of the fiscal impacts to the University; and

and submit the report to the Legislature no later than twenty days prior to the convening of the Regular Session of 2011.

SCHOOL YEAR AND INSTRUCTIONAL HOURS. Requires the Department of Education with the Board of Education and Office of the Governor and in consultation with representatives of the affected collective bargaining units to submit a plan to implement a school year of one hundred ninety days, excluding professional development days and other non-instructional days negotiated pursuant to chapter 89, Hawaii Revised Statutes, that shall include one thousand one hundred forty student instructional hours for both elementary and secondary school grades at all public schools to the Legislature no later than twenty days prior to the convening of the Regular Session of 2012.

DISASTER PREPAREDNESS PLAN FOR LEEWARD OAHU. BROADBAND SERVICES AND TECHNOLOGY, STREAMLINED PERMITS FOR. Resolves that the Legislature establishes a joint legislative investigating committee to oversee the investigation of the Department's handling of the State's investment in student loan auction rate securities (SLAR) and to assist the independent attorney in charge of the investigation by holding meetings and hearings as requested, receiving all information from the investigation, and submitting a final report to the Legislature.

- (A) Adopt rules for the conduct of its proceedings;

- (G) Provide for the submission, by a witness's own counsel and counsel for another individual or entity about whom the witness has devoted substantial or important portions of the witness's testimony, of written questions to be asked of the witness by the chair; and
- (H) Exercise all other powers specified under chapter 21, Hawaii Revised Statutes, with respect to an investigating committee; and

Further resolves that the committee shall consist of six members, comprised of one budget chair from the Senate, one budget chair from the House of Representatives, one majority member from the Senate who shall be appointed by the Senate President, one majority member from the House of Representatives who shall be appointed by the Speaker of the House of Representatives, one minority member from the Senate who shall be appointed by the Senate President, and one minority member from the House of Representatives who shall be appointed by the Speaker of the House of Representatives.

Further resolves that prior to issuing any subpoena for the testimony of any witness, or to calling any witness, the investigating committee shall determine whether litigation regarding the State's SLARS has been undertaken by the State, and, if not, shall inquire in writing of the Attorney General whether such litigation is reasonably likely; and if such litigation has been undertaken or if the Attorney General indicates it is reasonably likely, no such subpoena shall issue and no witness examined prior to the investigating committee receiving the written view of the Attorney General as to whether examination of such witness could materially harm the State's interests in such litigation; and if the written view of the Attorney General is in the affirmative, no subpoena shall issue and no examination of such witness shall take place absent the affirmative vote of four members of the investigating committee to issue such subpoena and conduct such examination.

Further resolves that the committee submit its written findings and recommendations to the Legislature no later than twenty days prior to the convening of the Regular Session of 2011.

Requests the Director of Taxation and CGI Technologies and Solutions, Inc. to cooperate with the Auditor to the fullest extent possible during the conduct of the management and financial audit.

Requests the Auditor to submit findings and recommendations to the Legislature no later than twenty days prior the convening of the Regular Session of 2011.

Requests the Department of Taxation to establish and implement a transition plan wherein department personnel shall assume all functions performed by employees of CGI Technologies and Solutions, Inc., under the current delinquent tax collection contract and to report to the Legislature on the development and implementation of the transition plan as soon as possible, but not later than August 31, 2010.

- (4) One member designated by the Hawaii Island Economic Development Board, Inc.;
- (5) One member designated by the Chairperson of the Public Utilities Commission;
- (6) The Hawaii Island Office of Hawaiian Affairs Trustee, or designee;
- (7) One member designated by the Director of Business, Economic Development, and Tourism;
- (8) One member designated by the Chairperson of the Board of Land and Natural Resources;
- (9) One member who is a representative of a non-profit, environmental group to be selected by the President of the Senate;
- (10) One member who is a representative of a cultural organization to be selected by the Speaker of the House of Representatives; and
- (11) One member representing West Hawaii to be selected by the Mayor of Hawaii County.

Resolves that the working group consider the potential impacts of expanding geothermal energy production on native habitats, pristine forest environments, and native Hawaiian

values and practices, and recommend mitigative measures to ameliorate any adverse impacts that may be caused by geothermal energy production expansion and to also consider what improvements may be required for the electricity transmission system and what funding may be available for such projects from the United States Department of Energy.

Further requests the working group to include a feasibility and cost-benefit analysis of using geothermal energy as the primary energy source to meet baseload demand on the Big Island, including an analysis of community, environmental, and economic benefits and that any community benefits analysis include the possibility and feasibility of establishing a community benefits package that includes the distribution of royalties derived from geothermal energy production to impacted communities, and strategies to avoid passing costs onto the customer.

Further requests the working group to include a detailed accounting of the geothermal royalties collected by the State, the County of Hawaii, and the Office of Hawaiian Affairs, including how those entities distribute and use the royalties.

Further requests the County to provide an interim report to the Legislature no later than twenty days prior to the convening of the Regular Session of 2011, and the final report no later than twenty days prior to the convening of the Regular Session of 2012.

DYSLEXIA, SUPPORT FOR PERSONS WITH. - (1) Increasing awareness of dyslexia;
- (2) Early assessment and identification of students with literacy challenges, including dyslexia;
- (3) A tiered continuum of intensity for research based instructional intervention within the Response to Intervention model;
- (4) Evidence-based progress monitoring that provides students, parents, and educators with data on student performance and improvements, and that uses this data in evaluations and decisions for instructional changes;
- (5) Research-based interventions to address the needs of students with literacy challenges, including dyslexia, consistent with guidelines established by the Partnership For Reading, comprising the National Institute of Child Health and Human Development, the National Institute for Literacy, and the United States Department of Education, based on findings of the National Reading Panel;
- (6) Practicum experience for educators in areas described in paragraphs (2) to (5);
- (7) Consistency with federal law regarding eligibility for services available for persons with specific learning disabilities; and
- (8) Encouraging coordination and collaboration between the Department of Education, the University of Hawaii, and other teacher preparation programs at institutions of higher education in the State.

Requests the working group to consider current educational policies, practices, and training with regard to literacy challenges, including dyslexia and review existing dyslexia-related legislation in other jurisdictions.

Requests the following to join the group:

- (1) A representative of the Department of Education;
- (2) A representative of the University of Hawaii;
